Davis-Bacon ACT (Wage Determination)	The Davis-Bacon Wage Determination & related Acts is issued by the U.S. Department of Labor. The Wage & Hour Division of the U.S. Department of Labor determines prevailing wage rates to be paid on federally funded or assisted construction projects. It is the responsibility of the federal agency that funds or financially assists Davis-Bacon covered construction projects to ensure that the proper Davis-Bacon wage determination(s) is/are applied to such construction contracts(s).
55 Character Project field. (Multi-Level Project Structure)	Up to 7 characters can be used to designate a top-level project. Projects can further be broken down into unlimited multi-tier sub-projects and tasks in this module. This multi-level/project feature enables users to add as many sub-projects as they require. System allows you to go down a Project Tree of up to 18 levels.

These types of projects support the Revenue/Expense matching principle. The WIP projects can be converted into "direct" projects, i.e. Fixed Price, Cost Plus, when the revenue and billing processes are ready to be run.
Project - Employee Assignment & Labor Category Assignment	Assigns employees to a specific project, enhancing accountability in management of project labor costs by allowing employees to one or more labor categories on a project, resulting in more accurate billing and revenue.
Project Budgeting & Cost Ceilings	Allows for tracking and monitoring budgets, cost ceilings both labor and non-labor costs at all levels of the project.
